The topic is within the scope of the WJG. (1) Classification: Grade A, Grade B, and Grade C; (2) Summary of the Peer-Review Report: The application of adipose-derived mesenchymal stem cells to study the therapeutic</p> | [Y] |

effect of patients with perianal fistula Crohn's disease is a very innovative and practical study. However, the number of case specimens is small. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 30 references are cited, including 14 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade A and two Grades B. No language editing certificate was provided. 3 Academic norms and rules: The authors didn't provide the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; (3) Authors should always cite references that are relevant to their study. And authors should not cite their own unrelated published articles. Please check and remove any references not relevant to this study; (4) The Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent should be
