The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: De novo malignancies are one of the leading mortalities causes late after liver transplantation, but it has been rarely reported in the literature the occurrence of multiple solid malignancies in the same patient. The questions raised by the reviewers should be answered;</p>	[Y]

and (3) Format: There is 1 table and 4 figures. A total of 21 references are cited, including 7 references published in the last 3 years. There is 1 self-citation (Ref. 8). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please rewrite the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (5) Authors should always cite references that are relevant to their study. Please check
