The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Based on the actual clinical problems, the study deeply revealed the persistent intestinal microecological disorders in patients with sepsis, and the intestinal</p>	[Y]

microecological disorders were correlated with inflammatory indicators and intestinal barrier indicators of sepsis, which provided certain evidence support for the treatment of clinical target diseases. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 8 figures. A total of 32 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Key Research and Development Program of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The “Article Highlights” section is missing.
