Language classification: Grade A, Grade B, Grade B, Grade B and Grade D. Scientific classification does not meet the publication standard of WJCC. The authors postulate a novel mechanism of liver toxicity, but they fail to substantiate this hypothesis. First, the basis of TMA diagnosis was described not enough. Second, because this</p>	[Y]

	<p>manuscript was based on wrong diagnosis, there were no novelty. Language needs a great deal of polishing.
