(1) Classification: Three Grades B and Grade C; (2) Summary of the Peer-Review Report: This complex and original research resulted in an elegant manuscript, written in a nicely manner, containing a lot of very important data from applying an integrative multi-omic analysis of colorectal cancer resection specimen. The overall structure of the manuscript is well respected. The questions raised by the reviewers should be answered. Please ignore the suggestion of adding a reference (PMID: 33182693) by the Reviewer 02839880; and (3) Format: There are 9 tables and 3 figures. A total of 38 references are cited, including 14 references published in the last 3 years. There are 3 self-citations (Ref. 4, 21, 28). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Two Grades A and two Grades B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Cancer Institute, Simons Foundation, Stony Brook University Targeted Research Opportunity seed fusion award. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not
