The **liver** is the dominant **metastatic** site for patients with CRC, and although two-thirds of affected patients have extrahepatic spread, some have disease that is isolated to the **liver**.

**Abstract**

Surgical resection for colorectal liver metastases (CRLM) may offer the best opportunity to improve the prognosis. However, only about 20% of CRLM cases are indicated for resection at the time of diagnosis (initially resectable), and the remaining cases are treated as unresectable (initially unresectable).
