Summary of the Peer-Review Report: In this manuscript, the authors aimed to study the plasma levels of three angiogenesis markers in HCC patients, and further evaluate the association between their levels and patient's prognosis. The article is interesting. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 5 figures; (4) References: A total of 30 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Three Grades B.
