The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors found an elaborate and topical review of the current guidelines on the use of radiotherapy in HCC. It is very well written and provides an updated account of the treatment of HCC.</p>	[Y]

However, some figures and diagrams about the mechanisms and techniques should be added; and (3) Format: There are 3 figures. (4) References: A total of 150 references are cited, including 55 references published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
