dysbiosis and prognosis in cirrhosis. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 21 references are cited, including 4 references published in the last 3 years. There are 2 self-citations (Ref. 19, 20). The topics of the self-citations are related to this study.

2 Language evaluation: Classification: Three Grades B and Grade C. A language editing certificate issued by Editage was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search.

4 Supplementary comments: This is an invited manuscript. The study was supported by BIOCODEX MICROBIOTA FOUNDATION: National Research Grant Russia 2019. The topic has not previously been published in the WJH.
