Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (3) Authors should not cite their own unrelated published articles.
