The topic is within the scope of the WJG. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: The article is well written and comprehensive review. It summarizes the pathogenesis, incidence, diagnosis, and treatment of GI disorders of</p>	[ Y]

systemic sclerosis for each GI organ. However, the spelling of acotiamide needs correction. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 133 references are cited, including 44 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The language classification is Grade C.
