The topic is within the scope of the WJD. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors concluded that the PAD-medical</p>	[Y]

score provides a simple way to assess implementation of medical management, which may have substantial benefit in reducing MACE. This article is well written and of clinical interest. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 39 references are cited, including 19 references published in the last 3 years. There are 16 self-citations (Ref. 4, 5, 8, 9, 13, 18, 23, 24, 25, 26, 27, 28, 29, 32, 33, 38). The topics of some self-citations are not very related to this study. 2 Language evaluation: Classification: Grade A and Grade B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. The written informed consent was not provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Health and Medical Research Council. The topic has not previously been published in the WJD. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please

	<p>add the "Article Highlights" section at the end of the main text; and</p> <p>(5) Authors should not cite their own unrelated published articles. Please check and remove any references not relevant to this study. 6</p> <p>Recommendation: Conditional acceptance.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Diabetes, and the manuscript is conditionally accepted.
