The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The case series appears interesting, however, the authors did not provide sufficient data to demonstrate that the transformation truly occurred. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A</p>	[Y]

total of 33 references are cited, including 21 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form. The Biostatistics Review Certificate was not provided. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
