The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors reported a hemodialysis patient diagnosed as CS vegetation and it was found accidentally by echocardiography. It has certain reporting value. However, some questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures.</p>	[Y]

A total of 33 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade C. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016. The authors need to provide the written informed consent signed by the patient. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
