The topic is within the scope of the WJD. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an important topic and highly relevant for our readers. In this review article authors presented summary of essential literature on glycemia and COVID-19 and plausible implicated pathways/mechanisms. Authors well presented the manuscript with great organization, flow and pertinent literature references.</p>	[Y]

The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 46 references are cited, including 46 references published in the last 3 years. There are 6 self-citations (Ref. 12, 13, 19, 35, 36, 39). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJD. 5 Issues raised: (1) The key word "COVID-19" is missing in the title. Please add it; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
