There are 1 tables and 9 figures; (4) References: A total of 41 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, PRISMA 2009 Checklist. No academic misconduct was found in the Bing search. 4 Supplementary comments: The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Recommendation: Conditional acceptance.
