2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the factors influencing the failure of interferon-free therapy for chronic hepatitis C. The topic is within the scope of the WJG. (1) Classification: Four Grades B and Grade C; (2) Summary of the Peer-Review Report: It is an interesting retrospective cohort study evaluating the factors influencing the failure of interferon-free therapy for chronic hepatitis C in a real-world settings. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 6 figures. A total of 32 references are cited, including 17 references published in the last 3 years. There are 5 self-citations (Ref. 1, 10, 12, 27, 28). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade A and four Grades B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Polish Association of Epidemiologists and Infectiologists. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
