The topic is within the scope of the WJT. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Good overview of obesity and hypertension influencing living donor kidney transplantation. The questions raised by the reviewers should be answered; and (3) Format: There are no tables and</p>	[Y]

figures. A total of 43 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors are native English speakers. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJT. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study; and (3) Please add table/figure to this review. 6 Recommendation: Conditional acceptance.
