Summary of the Peer-Review Report: The comments are good. The authors described the patient case with GPA who had CPA-associated severe enteritis, it was very interesting and well written. However, the questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 10 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the written informed consent. The authors need to provide the CARE Checklist-2016 with page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS",
