review of a group of congenital duplication cysts, comprehensive and appropriate. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 11 figures; (4) References: A total of 30 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (6) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Recommendation: Conditional acceptance.
