The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review</p>	[Y]

Report: The authors have written an extensive review on the hyperinflammatory and oxidative-stress responses to COVID-19 infection focusing on liver/GI tract injury. However, the chapter “Energy and nutrient recommendations” is repeated two times; and (3) Format: There are 3 tables and 5 figures. (4) References: A total of 217 references are cited, including 129 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer’s ID number to the editorialoffice@wjgnet.com.
