The topic is within the scope of the WJG. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: This is a very interesting</p>	[Y]

article, comparing endoscopic diagnostic between standard and M-NBI endoscopy for H. pylori infection. This article is valuable, because there are no guidelines for detection H. pylori infection by M-NBI so far. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 2 figures; (4) References: A total of 51 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
