The topic is within the scope of the WJSC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors study the potential of stem cells to be used in xenotransplantation. However, the questions raised by the reviewer should be answered; and (3) Format: There are no tables and figures. years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations.
