interesting study about the NCTD in the treatment of liver cancer. In this study a foundation for the liver-targeting ability of NCTD-IRMOF-3-Gel was developed. The methods are reasonable, and the interesting is very interesting. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 10 figures; (4) References: A total of 30 references are cited, including 18 references published in the last 3 years; (5) Self-cited references: There is no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A and two Grades B.
