The topic is within the scope of the WJCO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors summarized all driver mutations identified in patients with advanced NSCLC and provided the update about current targeted therapies for NSCLC patients with different mutations. very comprehensive, helpful information to both research and clinical community. However, the questions raised by the reviewer should be answered; and (3) Format: There is 1 figure. (4) References: A total of 126 references are cited, including 56 references published in the last 3 years; (5) Self-cited references: There are 12 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
