The topic is within the scope of the WJCC. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: Authors report a case of a 62 year old patient with a refractory</p>	[Y]

lung adenocarcinoma harboring a germline BRCA2 mutation who responded successfully to treatment with olaparib. The case is very interesting and very well studied. The way authors followed the case clinically and scientifically is excellent; (3) Format: There is 1 table and 1 figure; (4) References: A total of 12 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
