Summary of the Peer-Review Report: The authors have done a commendable job on outlining the impact of COVID-19 in clinical practice and summarizing the implications of the disease entity in IBD patients. This review contains within it all the information that the practitioners would need to manage IBD in the current pandemic. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 90 references are cited, including 78 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
