endoscopy. The review covers first the use of AI in detection of dysplasia in Barrett's esophagus and detection of colorectal polyps. The paper is well written. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 3 figures; (4) References: A total of 52 references are cited, including 24 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
