2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: This manuscript described a case for pancreatic paragangliomas. They reported that EUS-FNA cytology with immunohistochemistry could accurately diagnose pancreatic paragangliomas and differentiate them from other pancreatic tumors such as neuroendocrine tumors. In addition, they provided a comprehensive literature review of pancreatic</p>	[Y]

paragangliomas. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: An interesting and instructive case was shared, and a comprehensive literature review was conducted. The full text is not long, but concise and clear. Minor language polishing was suggested. Accept (General priority) was recommended; (3) Format: There are 5 figures and 1 table; (4) References: A total of 51 references are cited, including 3 references published in the last 3 years. More recent relevant references may need to be included; (5) Self-cited references: There are 0 self-cited references; (6) References recommendations: No improper references recommended by the peer reviewer(s). 2 Language evaluation: Classification: Grade B. Minor language polishing is suggested. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form, Copyright License Agreement, and the Institutional Review Board Approval Form if applicable. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: None. 5 Issues raised: (1) The keywords section is missing; (2) The language classification is Grade B.
