The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This manuscript reports the results of studies on the effect of gastric microbiota on the eradication rate of Hp in patients subjected to 14 days</p>	[Y]

quadruple Hp eradication therapy. It should be noted that the study was performed with relatively small number of patients. Moreover, the results and conclusions are not clearly accentuated. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 4 figures; (4) References: A total of 35 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
