(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript is good and informative, but some minor changes are required to be done before it can be accepted. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 8 figures; (4) References: A total of 106 references are cited, including 94 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately.

2 Language evaluation: Classification: Grade B. The authors are native English speakers.

3 Academic norms and rules: No academic misconduct was found in the Bing search.
