It is clear and well written. However, many data is unrelated to the proposed title; and (3) Format: There are no tables and figures. (4) References: A total of 415 references are cited, including no references published in the last 3 years; (5) Self-cited references: There are no self-cited references. The self-referencing rates should be less than 10%; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
