mixed reality, and 3-D navigation. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The report is an extensive review but not very innovative. There is a lack of discussion concerning the problem of real-time acquisition of images during the surgical procedure and real-time reconstruction. The authors do not discuss the specificity of real-time fluorescence which is significant part of the development in this field. In the same way, the review should take into account the recent application of fluorescence imaging during robotic surgery; (3) Format: There are 03 tables and 02 figures; (4) References: A total of 37 references are cited, including 08 references published in the last 2 years; (5) Self-cited references: There is 01 self-cited references. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e. those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
