In combination with the literature, the author interpret the imbalance of redox state in patients with sepsis/septic shock, and the continuous and excessive</p>	[Y]

production of hydrogen peroxide are the main factors with poor prognosis in patients with sepsis. The questions raised by the reviewers should be answered; (3) Format: There are 3 figures; (4) References: A total of 56 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
