It's well written and interesting; and (3) Format: There is 1 table and 4 figures. (4) References: A total of 31 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations.
