2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an editorial of the cancer recognition of artificial intelligence. The topic is within the scope of the AIC. (1) Classification: Grade D; (2) Summary of the Peer-Review Report: Reviewer 03850246's comment is invalid. This editorial describes how AI recognizes cancer and the potential application of AI-oriented cancer therapeutics. However, the editorial did not carry out a comprehensive review on the application of artificial intelligence technology in cancer treatment, only mentioned several common</p>	[Y]

algorithms, and failed to track the technological frontier. The questions raised by the reviewer should be answered; and (3) Format: There are no tables and figures. A total of 19 references are cited, including 13 references published in the last 3 years. There is 1 self-citation, which is related to this manuscript. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the AIC. 5 Issues raised: The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
