The topic is within the scope of the WJSC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report:</p>	[Y]

The authors reviewed the role of stem cells –derived bioactive factors including secretome and EVs in fighting COVID-19. The writing is clear and logical. It is also well organized. However, the questions raised by the reviewer should be answered; and (3) Format: There are 2 figures. (4) References: A total of 93 references are cited, including 51 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the [editorialoffice@wjgnet.com](mailto:editorialoffice@wjgnet.com). The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. Please revise throughout; (4) The references should be cited in the text in the Arabic number in order; and (5) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
