The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors presented a systematic review of existing published data of TIPS for cirrhotic</p>	[Y]

patients with portal vein thrombosis. It is a very interesting and important data. However, there are not enough publications that comprehensively evaluate this approach; and (3) Format: There are 2 tables and 2 figures. (4) References: A total of 27 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
