and Grade B; (2) Summary of the Peer-Review Report: The authors evaluated an association between endoscopic intervention and subsequent gastrointestinal bleeding (GIB) in patients with left ventricular assist devices (LVAD) using multivariate logistic regression. It's interesting and well-written. However, the questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. (4) References: A total of 6 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously
