authors presented a rare case of 68-year-old woman with IgG4-associated autoimmune hepatitis combined with giant-cell hepatitis. It is interesting and well-written. However, the quality of IgG4 staining is not sufficient. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. (4) References: A total of 29 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and

Please re-write the “Case Presentation” section, and add the “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” sections to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (3) The scientific quality can’t meet the requirement of WJG. 6 Recommendation: Transferring to the WJCC.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
