The topic is within the scope of the WJGO. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: The review is of interest, well performed and described. However, to better understand the core tip of the study it is recommended the inclusion of an explanatory figure about the pathway of</p>	[Y]

development of colorectal adenomas and the consequent progression to colorectal cancer. The questions raised by the reviewers should be answered; (3) Format: There is 1 table; (4) References: A total of 122 references are cited, including 72 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
