Peer-Review Report: The study examines the single weight of each PCDAI score item on disease activity, dividing them in subjective and objective items and showing also a combined score of only significant items. The quality of collected data is definitely high and interesting, and the body of the paper is nicely constructed with a regular flow. However, the questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. (4) References: A total of 27 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are 9 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing.
