Science Editor: 1 Scientific quality: The manuscript describes an editorial of the new trends in treatment of muscle fatigue throughout rehabilitation of elderlies with motor neuron diseases. The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: this is a very informative and clearly formulated editorial regarding an important topic, with conflicting evidence-base. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 10 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
