technical protocol exists for Ablation, which is a critical problem. It would be beneficial if the authors include the technical information given in the respective papers they have listed in their report. The questions raised by the reviewer should be answered;

(3) Format: There are 2 tables and 2 figures; (4) References: A total of 51 references are cited, including 15 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
