Peer-Review Report: This is a very valuable article. There are few published data on long-term outcome of pancreatic function and growth after pediatric pancreatic surgeries. The results presented in this paper are helpful for the reader to conduct better follow-up management of postoperative patients. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 1 figure; (4) References: A total of 42 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors didn't provide the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The "Author Contributions"

Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Article Highlights” section is missing.
