and described the type of lesion associated with each product with appropriate use of data sources. This paper raises awareness in the risks of medical and non-medical use of herbal products, and may benefit their applications in health care and maintenance. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 1 figure; (4) References: A total of 97 references are cited, including 18 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
