2	<i>Editorial Office's Comments</i> Science Editor: 1 Scientific quality: The manuscript describes an observational study of the modulated Electro-Hyperthermia as palliative treatment in stage III and IV pancreatic cancer. The topic is within the scope of the WJCO. (1) Classification: Two Grades B and Grade D; (2) Summary of the Peer-Review Report: It is a very	[Y]

well-designed study, with proper statistical methods and minor English discordances. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 2 figures; (4) References: A total of 22 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) PMID numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance. Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Clinical Oncology, and the manuscript is conditionally accepted. I have sent the manuscript to the author(s) for its revision according to the Peer-Review Report, Editorial Office's comments and the Criteria for Manuscript Revision by Authors. The title of the manuscript is too long and must be shortened to meet the requirement of the journal (Title: The title should be no more than 18 words).
