The topic is within the scope of the WJSC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors report a good effort to describe role of Stem Cell based therapy in current COVID-19 pandemic. It is interesting. reviewer should be answered; and (3) Format: There are no tables and figures. (4) References: A total of 62 references are cited, including 40 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors should provide some figures or tables; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The column should be minireviews. 6
