point of view seems to be well done. Tables lack a good structure. The Introduction and Background section is too long for a Case Report . The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 2 figures; (4) References: A total of 43 references are cited, including 39 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
