specified. 2. The necessity of vaccinating kidney transplant recipients from HBV-infected donors, the importance of HBIG and antiviral therapy, and the need for close follow-up after transplantation should be noted. 3. The cost of care for a patient on the waiting list should be compared with transplantation costs. The new criteria for emergency cases where HBV-infected donors may be used should be addressed, and it should be noted that, if possible, the waiting list may be an option for awaiting an HBV-free donor. All questions raised by the reviewer should be answered;
